<sup>1</sup> In order for the member fee to apply, the registrant's organization must be a member of CNA at the time of the Conference. If the organization's membership has lapsed (payment has not been received by CNA prior to the start of the Conference), the registrant will be required to pay the difference on-site before credentials will be issued.

All registration fees are subject to applicable taxes (currently 13% HST).

The conference fee does not include accommodations, non-program related meals, travel or any other expenses that may be incurred by delegates.

### **Pre-Conference Seminars**

Attendance at the pre-Conference Seminars is first and foremost a benefit for employees of CNA member companies who are fully registered for CNA2022. As of January 15, 2022, the remaining seats in the seminar will be open to all other registration categories and/or unregistered conference participants wishing to attend, until the room capacity has been reached. A variable fee structure will apply. Non-Conference participants that purchase the seminar are eligible to attend the welcome reception.

### **Exhibitors**

Exhibit booth staff are required to register as full conference registrants and pay any applicable fees. Each sponsorship opportunity and/or exhibit booth includes a number of complimentary registrations which may be used by booth staff or other representatives of the organization as decided by the organization. No additional complimentary registrations will be supplied for booth staff over and above the sponsor / exhibit agreement.

### **Young Professionals**

Discounted registrations for young professionals are available. To qualify for the rate, registrants must be under 35 years old and over 19 years of age on February 23, 2022 and must provide proof of age. Please upload a copy of your passport, driver's license or letter from your organization's Human Resources department attesting to your age.

### **Guest tickets to the Opening Reception**

Full Conference registrants may purchase tickets to the Opening Reception for \$130 for an accompanying guest. The cancellation policy above applies to these purchases.

### **Payment Terms**

To qualify for the Early Bird fee, registration and payment must be received by CNA by December 20, 2021, 5:00 pm (EST).

To qualify for the Regular fee, register by February 1, 2022, 5:00 pm (EST) and payment is received between December 20, 2021, 5:01 pm (EST) and February 1, 2022, 5:00 pm (EST).

The Late Registration fee will apply to all payments received after February 1, 2022, 5:00 pm (EST).

### **Registration Payment**

All Registration Fees may be paid by Credit Card (VISA, MasterCard or American Express), or by Cheque (payable to "Canadian Nuclear Association"). Registrations will not be processed or confirmed until payment in full is received. Post-dated cheques will not be accepted. Any bank charges incurred must be paid by the sender and not CNA.

## **Cancellations**

Cancellations for all categories are permitted until January 26, 2022, 5:00 pm (EST). Cancellations received by the applicable deadline will receive a full refund less a 25% administrative fee. Cancellations must be received in writing to Golden Planners by email (librado@goldenplanners.ca). No refunds will be made for cancellations received after the applicable deadline stated above or for no-shows. Substitutions from the same organization are permitted until February 9, 2022, 5:00 pm (EST) and must be submitted in writing as above. Substitution requests require full contact information for the new attendee along with the name of the attendee they are replacing.

## **Alterations to the Conference Program**

CNA reserves the right to make alterations without notice to the content, speakers, timing, venue or date of the conference compared to the advertised program.

## **Public Health Considerations**

Given that we expect the COVID-19 pandemic to be ongoing during the 2022 CNA Conference and Trade Show, changes may be required to address public health challenges. As a result, all plans, commitments and agreements with respect to the event, including all of those described or referenced in this document, may be modified in CNA's sole discretion. While CNA will endeavour to provide as much notice as possible of changes, the evolving nature of the pandemic may limit our ability to do so. In particular, CNA reserves the right to limit capacities to the conference and tradeshow and make any other required adjustments.

All attendees to the 2022 CNA Conference and Trade Show must follow public health measures in place at that time (including but not limited to masking, handwashing, physical distancing, etc.) In addition, attendees must show proof of vaccination (as provided by their jurisdiction of residence) in order to gain access to the event. Failure to provide such certification is not grounds for refund of any fees paid.

CNA will consider exceptions to its mandatory vaccination policy on a case-by-case basis. Generally, accommodations will be considered only for potential attendees who face extraordinary health challenges and for whom all of the available COVID-19 vaccinations are contraindicated. Unequivocal medical information from the individual's treating physician will be required to support an accommodation request. CNA will give due consideration to all reasons cited for an exemption to this policy in accordance with human rights legislation.

CNA may be limited in its ability to accommodate those who are not vaccinated by the venue owners, government regulations and/or public health. Furthermore, if CNA determines that an accommodation is warranted, certain conditions may be imposed on the unvaccinated attendee by which other attendees are not bound. Such conditions may be necessary to minimize the risk of COVID-19 transmission created by the accommodation measure. Some conditions may be imposed by governmental authorities, like Public Health.

An unvaccinated individual considering attending the event should inquire about the accommodation process prior to confirming attendance. Requests should be made in writing directly to [NAME]. The request must state the specific reason the individual seeks an accommodation, and any medical proof must be attached.

### **Acknowledgements**

The Conference Secretariat will send via e-mail a confirmation of Conference Registration and acknowledgement of payment once full payment has been received and processed. Internet registrations with credit card payments are processed and confirmed immediately by e-mail.

### **Privacy Policy**

CNA has contracted Golden Planners Inc. (GPI) to act as the professional conference organizer for the CNA2022.

In order to successfully hold CNA2022, CNA and GPI collect contact and personal information about registrants through conference registration forms. The achievement of the Conference's objectives involves, among other things, communicating with and determining the needs of registrants, processing payment relating to attendance at events or event related services and products.

Completion and submission of the registration form to CNA and/or GPI provides your consent to CNA and/or GPI to collect your personal information associated with your registration in order to communicate with you, process your conference registration and make any arrangements with third party service providers pertaining to your participation at CNA2022 (including the provision of this personal information necessary to complete your registration or any aspect of your participation).

A list of participants, including contact information, may be produced and distributed to registrants, sponsors and exhibitors. Unless a registrant objects, his/her contact information shall be used for these purposes. Contact information may include a registrant's name, title, department, organization, address, telephone number and email address as provided on the conference registration form. If a registrant does not consent, then his/her contact information shall be used by CNA and/or GPI solely for purposes of communicating with the registrant and shall not be provided to anyone else, except as provided for above to process the registration. In the event a registrant does not complete the Collection, Use and Disclosure of Information Section, the submission of a conference registration form constitutes the consent of a registrant to the use of his or her contact information for these purposes.

In accordance with Canada's anti-spam laws, the CNA will require expressed consent to contact you for commercial purposes outside of your participation at CNA2022 conference. Acceptance of these terms and conditions are mandatory for CNA2022 registration, and thus do not indicate your expressed consent for future communications. This consent will be collected separately during all CNA event registrations. Except as previously noted, your information will not be provided to any third party.

GPI will retain personal information provided to them only for so long as it is required for the purposes stated above. Information about former registrants is not actively maintained.
